NOMINATIONS

Nominations are invited for the following positions: **President (1), Vice President (1) and Ordinary Directors (5)**

Rule 27.3 of the Constitution of Bexley RSL and Community Club Limited states: Subject to this Rule and Rule 27.5, the following members shall be entitled to stand for and be elected or appointed to the Board:

- (a) Life members;
- (b) RSL members who have been financial members of the club for at least three (3) continuous years; and
- (c) Social members who have been financial members of the Club for at least three (3) consecutive years.

Nominations shall be in writing and signed by one and seconded by another Life members, a RSL member or Social members of the Club provided they have been financial members of the Club for a continuous period of at least 3 years, and by the candidate who shall signify his/her consent to the nomination.

Candidates may nominate for more than one position but may only be elected to one position.

LODGEMENT OF NOMINATIONS

Nominations can be collected 10.00am FRIDAY 22 FEBRUARY 2019 from The Secretary of the club and must be received NOT later than 12.00 NOON FRIDAY 8 MARCH 2019

A nomination cannot be withdrawn after this time and any defect must be rectified before this time.

Should more than the required number of nominations be received a draw will be conducted to determine the order of candidates' names on the ballot paper at the Club at 3pm on Friday 8 March 2019

CANDIDATE PROFILES

Candidates may submit a passport style photograph of themselves and may also complete a Candidate Profile form, which, along with the photograph, will be displayed at the club during the period of voting.

Photographs and candidate Profile forms must be lodged with the Secretary of the Club before the close of nominations at Noon, Friday 8 March 2019.

VOTING AT CLUB

Voting will take place at Bexley RSL and Community Club Limited, 24 Stoney Creek Road, Bexley.

Friday	22 nd March 2019	11am to 2pm & 4pm to 7pm
Saturday	23 rd March 2019	11am to 2pm & 4pm to 7pm

Eligible members are entitled to vote must produce their current membership card in order to receive a ballot paper.

The method of voting will be First Past the Post. Members must vote for the exact number to be elected in each ballot and should mark their ballot paper using crosses.

The counting of votes will take place at the Club at the completion of voting on Saturday 23 March 2019. The result of the election will be announced at the Annual General Meeting commencing at 10.30am, Sunday 24 March 2019. One scrutineer per Candidate may be appointed to witness the count.
